Dr. González actively participated in exchanges of knowledge related to:

1. the vasectomy guidelines of various countries,
2. evaluating candidates for vasectomy with particular attention to social, psychological, medical, and anatomical factors,
3. cleaning and sterilization of vasectomy instruments, including the MadaJet used to deliver no-needle anesthesia (autoclave sterilization vs. soak disinfection),
4. preparation of sterile vasectomy instrument trays,
5. patient counseling pre-vasectomy,
6. pre-vasectomy patient preparation, including consent, administration of pre-op meds, relaxation techniques, and site preparation,
7. isolation and positioning of the vas deferens,
8. no-needle anesthesia vs. mini-needle anesthesia,
9. exposure of the vas deferens using a no-scalpel technique,
10. performance of vasectomy using thermal cautery, division, and fascial interposition,
11. post-procedure counseling and clinical follow-up including post-vasectomy semen analysis,
12. management of complications including hematoma, infection, and post-vasectomy pain; and
13. evaluating and counseling candidates for vasectomy reversal.

Dr. González personally

1. contributed to both formal didactic presentations and less formal break-out sessions,
2. broadened his own perspectives with those of providers from overseas, and
3. shared and critiqued videos of a variety of vasectomy techniques.

During the five-day seminar, participants were engaged in active discussion about vasectomy for at least four hours per day and should be credited with 20 hours of continuing medical education.
